## Agreement –Read Carefully

1. Return the equipment in a clean condition or Lessor at This Location on the date and time herein specified: or within twenty-four (24) hours after receipt of the equipment if no time is specified unless other arrangements are made with the rental location; Pay a cleaning charge if the equipment is not cleaned before it is returned; Pay or reimburse Lessor for the full cost of all repairs or loss of the equipment resulting from accident, neglect, misuse, or failure to return the equipment.
2. Pay all rental charges at the daily or hourly rate from the time the equipment is received until it is returned. If the equipment is not returned by the date and time specified or within twenty four (24) hours after the equipment is received if no date and time are specified the Lessor shall have the right to take immediate action to recover the equipment. Renter agrees to pay all over time rental charges to Lessor as damages along with all costs and fees connected with recovery of equipment and/or collection of rental charge.
3. If Renter fails to return the equipment or if conditions or circumstances indicate theft and, upon written demand provided in accordance with the applicable state or local laws, Renter fails or refuses to return said equipment, Lessor may report the said equipment stole. Renter agrees to indemnify, defend and hold harmless Lessor, Proprietor, their employees and agents from any claim or liability arising out of Lessor's reporting the equipment stolen including any damages sought for false imprisonment, intentional or negligent infliction of emotional distress, false detention or any and all damages, losses or liabilities.
4. Not to loan sublet, pledge, transfer create a lien against, dispose of, or authorize another to use the equipment with the express written permission of the Lessor.
5. Use of the equipment, materials, and chemicals in a careful and prudent manner according to the instructions furnished by the Lessor.
6. Indemnify and hold Lessor and Lessor's agents free and harmless from any claim, demand, cause of action, or damage arising from personal injury or property damage as a result of the use of the rented equipment or chemicals used with it, or in any manner arising out of this Rental Agreement, including without limitation, attorney's fees and cost of suit.
7. To the extent permitted by any insurance policies Renter may have, including but not limited to homeowners liability property, or any other insurance policy, Renter hereby waives any right of it's insurer to subrogate against Essential Repair, its subsidiaries affiliates agents. Employees, officers, its licensees, their agents. Employees or officers. And rental Store with respect to any loss, damage, or injury of whatsoever kind arising out of incident to the rental purchase or use of any and all products or services hereunder.
8. By signing below, renter acknowledges that he/she has been instructed in the safe use of the machines. Essential Repair accepts no liability for consequences from misuse of the machines.
